

1 Findings:

2 1. The minor child of the parties, Robert Gerald Pfeifer (“Jerry”) born on May 16,
3 2003 has been taken, detained, and concealed by the Respondent Maria Misejova Pfeifer
4 (“Maria Pfeifer” or “Respondent”) in violation of an Order of this Court.

5
6 2. This Court has jurisdiction over the subject matter, parties, and the parties’ minor
7 child Robert Gerald Pfeifer (“Jerry”) born May 16, 2003. The Country of habitual residence
8 of the minor child is the United States of America and the State of California is the child’s home
9 state.

10
11 Orders

12 1. Pursuant to Family Code Sections 3130 through 3134.5, the District Attorney of
13 Los Angeles County is authorized and directed to conduct an investigation and to take all
14 actions necessary to locate the Respondent Maria Misejova Pfeifer (“Respondent”) and the
15 minor child Robert Gerald Pfeifer (“Jerry”) born May 16, 2003, and to procure compliance with
16 the custody order in the above-entitled matter by taking custody of the child Jerry and turning
17 him over to Petitioner Robert J. Pfeifer (“Petitioner”), and to assist in the enforcement of the
18 custody, visitation, and other orders of the Court by use of appropriate civil and criminal
19 proceedings (a *Family Code* section 3130 -3131 order).

20
21 2. Respondent shall forthwith return Jerry to the United States and to the custody and
22 care of Petitioner.

23
24 3. Respondent shall turn over Jerry’s passport to Petitioner forthwith.

26 4. Petitioner Robert J. Pfeifer is authorized to obtain a duplicate United States
27 passport for Robert Gerald Pfeifer (“Jerry”).

5. Petitioner is granted sole legal and physical custody of Jerry.

6. Respondent's custody and visitation with Jerry is terminated pending further Order of this Court and Respondent shall have no contact with the minor child.


7. The United States is the country of habitual residence of the child. The State of California is the child's home state for the purposes of the Uniform Child Custody, Jurisdiction and Enforcement Act. There are no other proceedings related to the child in any other jurisdiction at the time this Order is made. This Order is a child custody determination for the purposes of the Uniform Child Custody Jurisdiction and Enforcement Act.

8. Petitioner's child support obligation of \$523.00 per month is reduced to zero and terminated.
